#### Welcome

Hello fellow neighbors! I hope this February is treating everyone well. We recently had our Annual HOA Meeting for the neighborhood. This edition of the newsletter will focus on the topics we discussed during the annual meeting and give our residents a bird's eye view of what we have planned for the coming year.

#### **Capital Improvements FY2020**

Before the beginning of our current fiscal year, the HOA Board sat down to discuss and prioritize several capital improvements for our neighborhood. Below is a list of the major neighborhood projects we hope to accomplish during 2020:

- > AC/Furnace for Clubhouse replaced in January; \$7880 total cost
- French Drain around pool (runs along north/west sides of pool) replaced in Jan.; approx. \$3600
- Clubhouse Windows Obtaining bids currently
- HOA/Neighborhood Website Obtaining bids currently
- > Pool Furniture needing to replace about half of existing chaise loungers around pool

# **HOA DUES/Outstanding Dues/Lien Process**

HOA Annual Dues were due as of January 1, 2020. If you have not paid them, they are LATE and accounts will incur interest charges for any unpaid balance. - ➢ As a neighborhood, we currently have <u>\$19,852.05</u> in outstanding dues.
- Any home carrying a balance of \$1000 or greater in outstanding dues/fees, will receive a letter of intent to lien. This provides residence with at least 30 days to make payment in full or bring their balance below \$1000. If you are unable to make payment within the given time period, the HOA will begin the lien process on your residence and your residence will no longer have access to community amenities until the balance has been paid in full or brought below \$1000. Also please note, any legal/filing fees are the full responsibility of the resident in question. Liens will be released once the above criteria is met.

Please remember that our covenants call for approval by the Architectural Review Committee of all exterior changes to your home.
